

## Application for a national visa Employment for holders of an Academic Degree

For the application you require the following documents:

<input type="checkbox"/>	Valid <b>passport</b> (issued within the last 10 years and with at least two empty pages)
<input type="checkbox"/>	<b>Application form</b> & declaration (in accordance with Section 54 of the Residence Act) duly signed (2 copies)
<input type="checkbox"/>	<b>Declaration</b> for Additional contact and legal representation information (2 copies)
<input type="checkbox"/>	<b>3 current, identical biometric passport photos</b>
<input type="checkbox"/>	<b>Copy of your passport's data page</b> (A4 size copy) (2 copies)
<input type="checkbox"/>	<b>Annexure</b> for employment visa – two completed copies
<input type="checkbox"/>	<b>Declaration</b> in regards to <b>§ 18 AufenthG</b>
<input type="checkbox"/>	<b>“Declaration regarding a contract of employment”</b> (Erklärung zum Beschäftigungsverhältnis), completed and duly signed by the employer
<input type="checkbox"/>	<b>Proof of academic qualifications</b> , e. g. Master's Degree, Bachelor's Degree
<input type="checkbox"/>	<b>Proof</b> that your <b>studies done in presence</b> or, if done remotely, confirmation by the relevant Indian authority that this <b>distance learning was approved</b> at the time of your degree.
<input type="checkbox"/>	<b>Proof of recognition of your academic qualification</b> in Germany: <ul style="list-style-type: none"> <li>- 2 copies from the <a href="#">Anabin website</a> of the recognition of the <b>academic degree</b> as well as the <b>University</b> (Degree mentioned as “entspricht” or “gleichwertig”, University mentioned as “H+”,)</li> </ul> OR <ul style="list-style-type: none"> <li>- Original and 2 copies of the recognition (“<b>Zeugnisbewertung</b>”) of the non-german degree by the Central Office for Foreign Education, ZAB (<a href="#">Zentralstelle für ausländisches Bildungswesen</a>).</li> </ul>
<input type="checkbox"/>	If applicable: <b>Professional practice license (Berufsausübungserlaubnis)</b> issued by the relevant recognition body in original and 2 copies For certain regulated professions, a professional practice license is required, for example for medical doctors, engineers, teachers etc.
<input type="checkbox"/>	If you meet Blue Card requirements or are unsure: <b>Declaration</b> in regards to <b>§ 82 AufenthG</b>
<input type="checkbox"/>	If applicable: <b>Pre-Approval</b> by the Federal Employment Agency NOT applicable for a salary above 45.300,-- € annually
<input type="checkbox"/>	<b>Curriculum Vitae</b>
<input type="checkbox"/>	For applicants who are <b>45 years old or older</b> and whose yearly salary is below 49.830,-- €: document of proof of adequate contribution to a German Pension fund / pension insurance
<input type="checkbox"/>	Confirmation of <b>compulsory health insurance</b> and/or <b>Travel Health Insurance</b>

All documents need to be presented in original plus TWO copies (A4 size).

Please note that the German Mission in India reserves the right to request additional documents.

The submission of the above-mentioned documents does not guarantee that a visa is granted. Submission of incomplete documentation or refusal to appear for a visa interview may result in the rejection of your application. Making untrue statements and/or handing in documents that do not reflect the truth will result in a rejection of your application
