¹ **The Kingdom of Spain** on the occasion of the deposit of the notification of the completion of the national approval procedures, declared the following:

(Translation, Original Spanish)

"Spain, as a participant State, stands ready to contribute to the construction and operation of the European XFEL Facility. However, the obligations that Spain will undertake upon signing the European XFEL Convention are as follows:

- 1. Two years after the beginning of the operation phase, Spain will review its active participation in this phase and will have the option of withdrawing without incurring any kind of penalty, provided that it gives one year's notice.
- 2. In the event of a positive review, Spain may extend its participation for an additional three-year period, without prejudice to the applicable review cycle, and maintain its participation throughout the entire process.
- 3. In the event that it decides to continue to participate in the process after the first review, Spain will fully assume its responsibility regarding the dismantling of the facility, pursuant to the Convention. In the event that Spain, on the basis of its first review, decides to withdraw, it would only accept 50% of its responsibility for the dismantling of the facility, pursuant to the Convention."

of the Government of the United Kingdom of Great Britain and Northern Ireland

² The United Kingdom of Great Britain and Northern Ireland on the occasion of the deposit of the notification of the completion of the national approval procedures, declared the following:

"The United Kingdom of Great Britain and Northern Ireland is willing to contribute as a participating state to the establishment and utilisation of the European XFEL Facility. Nevertheless, the United Kingdom of Great Britain and Northern Ireland's obligations on signing the Protocol to the Convention concerning the Construction and Operation of a European X-Ray Free- Electron Laser Facility on the Accession of the Government of the United Kingdom of Great Britain and Northern Ireland shall be as follows:

- 1. This Declaration shall replace any previous Declaration of the United Kingdom of Great Britain and Northern Ireland (the 'UK').
- 2. Article 24 on Confidentiality in the Articles of Association (Annex to the Convention) should be interpreted as follows in order to meet the requirements of the UK's Freedom of Information Act 2000: the UK's shareholder in European XFEL GmbH will not be in breach of Article 24 in circumstances where (i) it is compelled to disclose confidential information in response to a relevant request under the Freedom of Information Act 2000, (ii) following consultation with the European XFEL GmbH, none of the exceptions to that Act can be applied to the requested confidential information and (iii) refusal to disclose the information requested would result in a breach of the Freedom of Information Act 2000 by the UK authority serving as the UK's shareholder.
- 3. In the event of a conflict of terms of the various documentation relating to the UK's participation in XFEL, the following order of precedence shall apply: 1. This Declaration, 2. Protocol to the Convention concerning the Construction and Operation of a European X-Ray Free-Electron Laser Facility on the Accession of the Government of the United Kingdom of Great Britain and Northern Ireland, 3. The Convention, 4. The Articles of Association of the European XFEL GmbH."
