## Checklist for a German National Visa

- FAMILY REUNIFICATION REFUGEE (PARENT) -

You can apply for this visa, if you are a parent of a MINOR child who is living in Germany and has a valid refugee status (§25 Abs. I or II 1. AufenthG) in Germany.

Before booking an appointment, please prepare the following documentation for your visa. The following documents are to be submitted **personally** at the Embassy **after booking** an appointment.

## **IMPORTANT:**

- 1. Please provide the <u>original documents</u> in the **first (1.) pile** in the below mentioned order!
- 2. Please also provide two copies of all documents in two (2) identical piles!
- 3. The Embassy reserves the right to request additional documents.

## **DOCUMENTS:**

Fully completed and signed application form for "national visa" (here)
Where applicable: <u>Declaration</u> fully completed and signed regarding contact details and power of attorney
Valid passport (valid for at least 6 months and with at least two (2) completely empty pages)
Recent <b>biometric passport photos</b> (see specimen photos, other photos cannot be accepted and delay the visa process)
<b>Explanation letter of parent</b> indicating the address where the applicant will stay in Germany and explaining the situation
Copy of the passport of the minor child who lives in Germany
Official <b>certificate of recognition as a refugee</b> of the minor child who lives in Germany
<b>Original legalized birth certificate of applicant</b> ("acte de naissance") (if it is a non-Rwandan certificate the authentication might have to be certified by the German Embassy of the respective country)
<b>Original legalized birth certificate of child</b> ("acte de naissance") (if it is a non-Rwandan certificate the authentication might have to be certified by the German Embassy of the respective country)

	Health insurance upon entry for at least 90 days of your stay that adheres to Schengen rules and regulations.  In its terms and conditions, travel health insurance can exclude protection if a long-term or permanent stay is planned. So-called incoming travel insurance can also contain such exclusions.
	Proof of adequate <b>health insurance</b> cover
	If applicable: Legalized acknowledgement of paternity
	If applicable: <b>legalized proof of change of custody</b> (e.g. court order, documents about adoption, death certificate of parent)
	if applicable: <b>legalized original marriage certificate</b> ("acte de mariage") of the parents (if it is a non-Rwandan certificate the authentication might have to be certified by the German Embassy of the respective country)
